Processing aging and packaging, also under-vacuum, of fresh, aged and flavoured cheese, made with sheep's milk, mixed cow's and sheep's milk, mixed cow's, sheep's and goats' milk and goat's milk pasteurized or raw milk. Processing and packaging, also vacuum-packed, of fresh sheep's, mixed and goat's ricotta.
